3. Prof Anurita Joshi, report head of the Grievance Cell @ BNCA apprised the committee of the cases addressed by the students grievance cell & the action taken by the Grievance Committee.

4. The program of the students' Final Year thesis was discussed. Dates for the Consultants Meta were discussed. Dates for the Mega Jury were also discussed. March & Aprth 2019 were finalized as dates for the mega Jury. Budget for the same was also discussed. List of jury members was presented by Prof. Shubhada Kamalapurkar & Prof. Dhruv Chardwani.

5. The state of students' attendance in classes & studios was discussed. Concern was raised about subjects that do not have Sessional Exams. Review was also taken of the systems used by the college till date to record & ensure attendance.

It was decided to withhold results of the in-semester exams of those students who were defaulters in attendance for the subjects for which in-semester exams were conducted.
